ORDINANCE NO. 2454

**ORDINANCE AMENDING ORDINANCE NO. 2184 REGULATING TRASH AND  
REFUSE COLLECTION IN THE VILLAGE OF CROOKSVILLE,  
PERRY COUNTY, OHIO**

**Whereas**, pursuant to Ohio Revised Code § 715.43, any municipal corporation may provide for the collection and disposition of garbage and refuse;

**Whereas**, in accordance with Ohio Revised Code § 715.43, the Village of Crooksville previously adopted Ordinance No. 2184, enacted July 3, 1995, regulating trash and refuse collection in the Village of Crooksville;

**Whereas**, the Village of Crooksville previously adopted Ordinance No. 2425, enacted December 19, 2011, amending Ordinance No. 2184, but amending said Ordinance only to the extent of increasing the permit application and renewal fee; and

**Whereas**, the Village Council now desires to amend Ordinance No. 2184, enacted July 3, 1995, only to the extent necessary to revise and institute a new allowable schedule for trash pick-up within the Village.

**NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED** by the Village of Crooksville, Perry County, State of Ohio, that:

Section 1. **Allowable Pick-Up**. Paragraph 10. of Ordinance 2184 is hereby AMENDED and replaced with the following:

Days/Times of Collection; Holidays: Permit holders shall only pick up refuse, garbage and/or trash from or for its customers within the corporate limits of the Village of Crooksville between the hours of 6:00am and 9:00pm, on Tuesdays and/or Thursdays. Should a scheduled collection fall upon a holiday, collection shall be made the following day.

Section 2. This amendment shall affect only the paragraph and section noted, and shall not affect any other portion of Ordinance No. 2184, or its previously amending ordinance, Ordinance No. 2425, as a whole.

Section 3. This Ordinance shall go into effect at the earliest date allowed by law.




