

ORDINANCE REGULATING TRASH AND REFUSE COLLECTION
IN THE VILLAGE OF CROOKSVILLE, PERRY COUNTY, OHIO

BE IT ORDAINED by the Village Council of the Village of Crooksville, Perry County, Ohio:

1. Each person, firm or corporation collecting trash, refuse and/or garbage within the corporate limits of the Village of Crooksville, Perry County, Ohio, shall obtain a permit from the Village which shall be issued by the Village approved and signed by the Mayor of the Village.
2. Each person, firm or corporation shall obtain an application from the Clerk, complete the application and return it to the Clerk for processing by the Village Council.
3. The applicant shall, at the time of obtaining the application, deposit fifty dollars (\$50.00) for the calendar year in which the application for the permit is filed. The permit shall be renewed each January 1st upon submission of application for renewal and the payment of fifty dollars (\$50.00) annual permit fee.
4. The application shall contain:
 - A. The applicant's full legal name, address, telephone number, and the responsible person to be contacted by the Village Clerk for any official communication.
 - B. A full description of any equipment the applicant will use in the collecting process within the Village.
 - C. The name and address of the applicant's insurance carrier and the amount of liability for injury to persons and property which amount shall not be less than \$500,000.00 for each occurrence.
5. Any person, firm or corporation issued a permit shall be responsible for damages to municipal property, including streets and alleys. Further, the permit holder shall be liable for damages to private property.
6. Claims shall be submitted to the permit holder through the Village Clerk, who shall bring them to the attention of Village Council, which shall then present them to the permit holder.
7. All claims submitted to the permit holder shall be settled by binding arbitration, consisting of a representative of the permit holder, village council and a representative of the public living in the Village of Crooksville, Ohio.

8 All persons, firms and corporations issued a permit to collect, transport and dispose of trash, refuse and/or garbage shall be bound by all the laws, rules and regulations of the State of Ohio, the Solid Waste District which governs Perry County, Ohio, and the Perry County Health Department.

9. The permit holder is responsible for obtaining a site location and/or landfill in which to deposit the collected trash, refuse and garbage, all of which is at the permit holder's expense.

10. The permit holder shall only pick up trash, refuse, and/or garbage between 6:30 a.m. and 9:00 p.m. each day of the week except Sundays, and New Years Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, and Christmas Day.

11. The permit holder shall determine the charges made for the service rendered by it to its customers.

12. The permit holder shall file a list of its customers's names and addresses, together with its charges with the Village Clerk prior to rendering any service to its customers. The list shall be updated on the first day of each calendar quarter.

13. Any person, firm or corporation providing casual or regular services to any residences of the Village of Crooksville without a permit shall be subject to a fine of fifty dollars (\$50.00) for the first offense and one hundred dollars (\$100.00) for a second offense. Each violation shall constitute a separate offense. Failure to pay any fine within fifteen (15) days will be automatic forfeiture of the permit.

14. This ordinance shall be read and voted on at three regular meetings.

ORDINANCE NO. 2425

**ORDINANCE AMENDING ORDINANCE NO. 2184 REGULATING TRASH AND
REFUSE COLLECTION IN THE VILLAGE OF CROOKSVILLE,
PERRY COUNTY, OHIO**

Whereas, pursuant to Ohio Revised Code § 715.43, any municipal corporation may provide for the collection and disposition of garbage and refuse;

Whereas, in accordance with Ohio Revised Code § 715.43, the Village of Crooksville previously adopted Ordinance No. 2184, regulating trash and refuse collection in the Village of Crooksville; and

Whereas, the Village Council now desires to amend Ordinance No. 2184, enacted July 3, 1995, only to the extent necessary to revise and institute a new permit fee and a new permit renewal fee.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village of Crooksville, Perry County, State of Ohio, that:

Section 1. **Permit Fee and Permit Renewal Fee.** Paragraph 3. of Ordinance 2184 is hereby AMENDED and replaced with the following:

The applicant shall, at the time of obtaining the application, deposit Two Hundred and No/100 Dollars (\$200.00) for the calendar year in which the application for the permit is filed. The permit shall be renewed each February 1st upon a permit holder's application for renewal and the payment of Two Hundred and No/100 Dollars (\$200.00) annual permit fee.

Section 2. This amendment shall affect only the paragraph and section noted, and shall not affect any other portion of Ordinance No. 2184 as a whole.


Section 3. This Ordinance shall go into effect at the earliest date allowed by law.
