

Village of Crooksville
Council Workshop Meeting
January 08, 2024

Mayor Mohler calls the meeting to order with the following Council Members present: Mr. Hampton, Mr. Locke, Mr. Loomis, Mr. Redfern, Ms. Smith and Mr. Walters. Lacey Tumblin and Courtney Edwards were also present.

First up on the agenda, Ms. Tumblin let council look over the Star Ohio papers from November & December if anyone had any questions.

Next, Courtney Edwards discussed the Ohio Ambulance Transportation Grant. She stated that we did get approved for the \$20,000 and will be working on that Friday.

Next, we did receive the \$2000 for Safe Street money. Perry County Mobility Management reached back out regarding the buses and transit shelters and where we would like them placed. Mayor Mohler stated that he believes one should be put at the corner of W Main St and S Buckeye St. We own the little property right on the corner.

Up next, Mrs. Tumblin stated that Ben Carpenter and Jessica from the Perry County EMA were in last week to discuss the Flood Plain Manager. We have Ordinance, 2411, to make Ben Carpenter our Flood Plain Manager. The only changes to the Ordinance would be from Ben to Jessica and from Perry Soil & Water to the Perry County EMA.

Next, Mrs. Tumblin wanted to discuss the Archery at the Rec Center. The program has only brought in \$1,530.00 since 2016. Mr. Hampton stated that maybe they move it from 8-10:00am. Not to completely get rid of the program. Mr. Loomis stated that he is against keeping the program if it only brought in \$30.00 in 2023. Mr. Locke and Mr. Redfern agreed.

There was a very big leak found at the Rec Center that we were losing an estimated 60-80 gallons a minute.

Up next, Mrs. Tumblin has a couple quotes to share with Council. The first is from Willet Construction, to repair metal and brick at Beaumont building after the accident, for \$2000. The second quote, from Modern Glass, is for the glass doors that had been discussed and the other, from Tri-County, is for an overhead garage door. There was a brief discussion on whether or not to sell the Beaumont Building. They would like to vote on it next week. Mr. Loomis is stating they should just go with the glass doors.

Daryl Newlon passed out papers for a couple new EMT's. Joanna Gilman and Lisa McGee.

Darrell Wallace stated they got the crash report on 216 and forwarded that to insurance. He discussed the portrait fundraiser that they are continuing for the Fire Station.
