**RESOLUTION TO AWARD A CONSTRUCTION CONTRACT FOR
THE LIFT STATIONS B1 & B6 REPLACEMENT PROJECT**

WHEREAS, the Village of Crooksville wishes to construct improvements to its existing sanitary sewer system; and

WHEREAS, on August 8, 2024, one bid was received for the Lift Stations B1 & B6 Replacement project; and

WHEREAS, the Village Council wishes to award the contract to the recommended best bidder; and

WHEREAS, said recommended best bid is The Righter Co., Inc. in the amount of \$3,119,000.00.

WHEREAS, the Engineer, Verdantas LLC, has recommended awarding the bid as detailed above; and

WHEREAS, the Village Administrator shall be authorized to execute the Notice of Award and the Agreement for the Construction Contract as all funds are secured.

NOW THEREFORE, be it **RESOLVED** by the Village of Crooksville of Perry County, Ohio:

SECTION 1. This Council approves and awards for construction of the Lift Stations B1 & B6 Replacement project to The Righter Co., Inc. for a contract amount of \$3,119,000.00.

SECTION 2. The Village Administrator is hereby authorized to sign all documents for and enter into an agreement for the said contract for the construction of the Lift Stations B1 & B6 Replacement project on behalf of the Village Council of the Village of Crooksville.


SECTION 3. This Resolution is hereby declared an emergency measure to expedite the award of the contract, signing of agreements and to expedite the overall project to promote the needs of the Village's sanitary sewer system. Following appropriate legislative action, as an emergency measure, this Resolution shall take effect and be in force immediately upon its passage and approval.

Work also includes excavation, concrete, electrical upgrades, demolition of the two existing lift stations, and installation of 500' feet of 10" PVC force main and four gravity sewer manholes.


