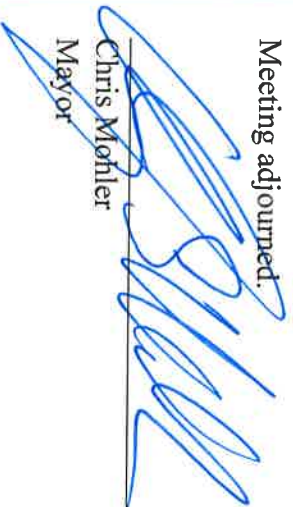
Motion to accept Resolution #13-2025. A motion was made by Mr. Walters and seconded by Mr. Loomis.
