A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A GAS SUPPLY AGREEMENT WITH NEW WAVE ENERGY, LLC FOR THE VILLAGE'S GAS FACILITIES ACCOUNTS AND DECLARING AN EMERGENCY

WHEREAS, Aspen Energy Corporation is an entity certified by the Ohio Public Utilities Commission to provide competitive retail Gas Aggregate Power Broker Services within the State of Ohio; and

WHEREAS, Aspen Energy Corporation presented the Village of Crooksville with an opportunity to secure its Gas supply needs from New Wave Energy, LLC, at a significant savings over that by which the Village has previously secured its Gas supply needs; and

WHEREAS, the Village of Crooksville requires Gas supply at each of its various facilities; and

WHEREAS, the Council of the Village of Crooksville has determined it appropriate and in the best interests of fiscal responsibility and the general welfare of the Village to authorize the Village Administrator to enter into a Gas Supply Agreement for the Village's facilities for a twelve month period commencing March ______, 2025; and

WHEREAS, the Council of the Village of Crooksville has deemed it necessary to pass this Resolution as an emergency measure so as to allow sufficient time to commence its Gas supply savings at the earliest possible supply period.

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

SECTION 1. Lacey Tumblin, Village Administrator, is hereby authorized to enter into a Gas Supply Agreement for Gas energy for each of the Village's facilities, for a twelve month period commencing March ______, 2025, in accordance with the terms of that certain Gas Supply Agreement brokered by Aspen Energy Corporation, a copy of which is attached hereto and incorporated herein by reference.

SECTION 2. This Resolution is hereby declared an emergency measure and shall become effective upon passage, in order to allow sufficient time to commence significant Gas supply savings for the Village's facilities at the earliest possible supply period, in the best interests and general welfare of the Village of Crooksville.
