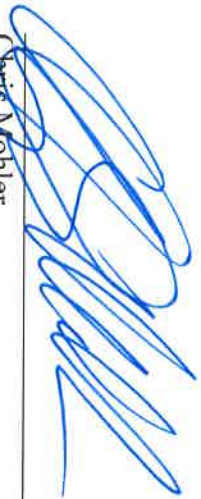
Out of Executive Session.
