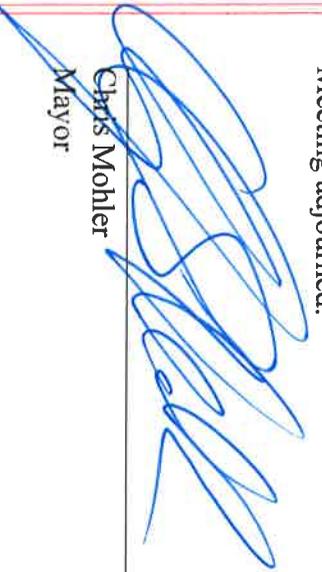
Mrs. Tumblin stated that the parade and Christmas lighting at the park was a great turnout, and everything went great. The guys did a great job.
