**RESOLUTION No. 105-2025**

**RESOLUTION ADOPTING AN UPDATED PARTICIPATION POLICY FOR THE  
VILLAGE OF CROOKSVILLE FIRE AND EMS DEPARTMENTS'  
STANDARD OPERATING PROCEDURES MANUAL**

**Whereas**, the Village of Crooksville Fire and EMS Departments, with approval of the Mayor and Village Council, have previously adopted and implemented Standard Operating Procedures (“SOPs”) for the safety and governance of its Officers, Members and Employees; and

**Whereas**, the Village of Crooksville Fire and EMS Departments’ Officers, together with the Mayor, Village Administrator and Village Council have identified a need to review and update those SOPs and will proceed to do so in various stages; and

**Whereas**, an updated Participation Policy establishing rules, guidelines, requirements and responsibilities for Fire and EMS Run Participation, Training Participation, and Continuing Education has been drafted, reviewed and submitted for approval; and

**Whereas**, the Legislative Authority approves and desires to adopt and implement the updated Participation Policy as part of the Village of Crooksville Fire and EMS Departments’ Standard Operating Procedures.

**NOW THEREFORE**, a majority of the members of the Council of the Village of Crooksville, Perry County, Ohio, concurring therein, **BE IT, THEREFORE, RESOLVED:**

**Section 1:** That the Village of Crooksville hereby adopts and implements the updated Participation Policy attached hereto and incorporated herein by reference as part of the Village of Crooksville Fire and EMS Departments’ Standard Operating Procedures.

**Section 2:** That the updated Participation Policy shall replace the previous Participation Policy and shall have immediate effect upon passage of this Resolution.

**Section 3:** That the Chief(s) shall cause the updated Participation Policy to be added to the Village of Crooksville Fire and EMS Departments’ Standard Operating Procedures, and shall remove from the SOPs the previous Participation Policy; and that the Chief(s) shall cause notice of the adoption of the updated Policy and its contents to be provided to each of the Departments’ current Officers, Members and Employees.

That this Resolution is effective at the earliest date allowed by law.


