RESOLUTION NO. 13-2025

**RESOLUTION AUTHORIZING THE VILLAGE OF CROOKSVILLE TO ENTER
INTO AN AGREEMENT WITH YORK TOWNSHIP, PERRY COUNTY TO PROVIDE
AND FIRE PROTECTION SERVICES (FPS) TO YORK TOWNSHIP
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Crooksville has Volunteer Fire Protection Services (FPS) physically situated in close proximity to York Township, Perry County, and is therefore able and desires to provide York Township with Volunteer Fire Protection Services (FPS); and

WHEREAS, York Township lacks sufficient Fire Protection Services (FPS) and therefore the Township desires the Village of Crooksville to provide York Township with Fire Protection Services (FPS) for the health, safety and welfare of the residents of York Township; and

WHEREAS, the Ohio Revised Code under Section 735.053 allows for the Village of Crooksville to enter into an agreement to provide Volunteer Fire Protection Services (FPS) to York Township; and

WHEREAS, upon the foregoing, the Village Council desires the Village of Crooksville, acting through its Mayor, Village Administrator and Fire Chief, to enter into a new agreement with York Township to Volunteer Fire Protection Services (FPS) to York Township pursuant to Ohio Revised Code Section 735.053 and as otherwise allowed by law.

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

SECTION 1. In accordance with Ohio Revised Code Section 735.053, the Village of Crooksville, acting through its Mayor, Village Administrator and Fire Chief, is hereby authorized

and instructed to enter into a new agreement with York Township to provide Volunteer Fire Protection Services (FPS) to York Township, upon the terms and conditions set forth in said agreement, a copy of which is attached hereto and incorporated herein by reference.

SECTION 2. That this Resolution is declared an emergency measure necessary for immediate effectiveness on its passage in order to allow for timely effect pursuant to commencement date called for under the agreement and in order to provide funds necessary to the fiscally responsible and efficient administration of the Village's Volunteer FPS Department, all in the best interests and general welfare of the Village of Crooksville. This Resolution is therefore effective upon its passage.
