RESOLUTION NO. 32-2025

**RESOLUTION PROVIDING FOR AN INCREASE OF \$0.75
TO THE HOURLY RATE OF PAY FOR EACH OF THE CURRENTLY-EMPLOYED
HOURLY FULL-TIME EMPLOYEES AND FOR PART-TIME EMPLOYEE RODNEY
EDGEELL, AND AN EFFECTIVELY EQUIVALENT INCREASE OF \$1,560.00 TO THE
ANNUAL SALARY FOR EACH OF THE CURRENTLY-EMPLOYED SALARIED
EMPLOYEES (VILLAGE ADMINISTRATOR, VILLAGE FISCAL OFFICER,
AND FIRE CHIEF) OF THE VILLAGE OF CROOKSVILLE**

Whereas, the Village of Crooksville has heretofore adopted an Ordinance providing a manual for employee policies and procedures, to wit Ordinance No. 2466, adopted September 16, 2013, and an Ordinance amending and replacing Exhibit A to that manual, to wit Ordinance No. 2540, adopted September 8, 2015, and an Ordinance adding the position of Assistant Police Chief, adding certain job descriptions and again replacing Exhibit A to that manual, to wit Ordinance No. 2627, adopted September 17, 2018, and an Ordinance adding education, training and policy requirements mandated by ORC 109.43 and 149.43(E)(1) and again replacing Exhibit A to that manual, to wit Ordinance No. 2694, adopted April 5, 2021, an Ordinance again replacing Exhibit A and also replacing Exhibit C, to include the pay for and position of Full Time Fire Chief, to wit Ordinance No. 2701, adopted September 7, 2021; an Ordinance again replacing Exhibit A to that manual, to wit Ordinance No. 2724, adopted February 21, 2023; and an Ordinance amending vacation earned and again replacing Exhibit A to that manual, to wit Ordinance No. 2735, adopted April 1, 2024;

Whereas, the Village Council desires to act in accordance with the aforementioned Ordinances, and to provide for an increase of \$0.75 to the hourly rate of pay for each of the currently-employed hourly full-time employees, and for part-time employee Rodney Edgell, and an effectively equivalent increase of \$1,560.00 to the annual salary for each of the currently-employed salaried employees (Village Administrator, Village Fiscal Officer, and Fire Chief); and

Whereas, the Village Council desires for such raises to apply to each of the employees specifically named on the attached Exhibit A, and that such raises will not apply to any employee who is not specifically named on Exhibit A, such employees not having moved beyond their probationary periods of employment so as to be appropriately eligible for a raise.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village of Crooksville, Perry County, State of Ohio, that:

1. Acting in accordance with Ordinance #s 2466, 2540, 2627, 2694, 2701, 2724, and 2735, Village Employee pay is modified and amended ONLY to the following extent:
 - a. Current Hourly Full-Time Employees, and Part-Time Employee Rodney Edgell, of the Village of Crooksville, named as identified on attached Exhibit A, shall have an increase of \$0.75 to the hourly rate of the employee's pay, effective upon passage of this Resolution.
 - b. Current Salaried Employees of the Village of Crooksville (Village Administrator, Village Fiscal Officer, and Fire Chief), named as identified on attached Exhibit A, shall have an

increase of \$1,560.00 to the employee's annual salary, effective upon passage of this Resolution.


2. This Resolution shall have effect at the earliest date allowable by law.
