## **RESOLUTION NO. 90-2025**

## A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE AN AGREEMENT WITH OHIO DEPARTMENT OF NATURAL RESOURCES (ODNR) TO ACCEPT AND ADMINISTER A PARKS AND RECREATION IMPROVEMENT FUND GRANT OBTAINED FOR THE CROOKSVILLE WADE POOL REHABILITATION, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Crooksville is the recipient of a \$63,700 Parks and Recreation Improvement Fund Grant (the "Grant") through the Ohio Department of Natural Resources (ODNR), all but \$1,300 retained by ODNR for administration expenses, to be used toward the cost of the CROOKSVILLE WADE POOL REHABILITATION project; and

WHEREAS, upon award of the Grant, the Village of Crooksville received a Capital Improvement Community Park, Recreation/Conservation Project Pass-Through Grant Agreement from ODNR, for which the Village Council recommends entering said Agreement with ODNR to accept and administer the Parks and Recreation Improvement Fund Grant for to be used toward the total cost of the Village's CROOKSVILLE WADE POOL REHABILITATION Project that was approved for funding; and

WHEREAS, the Village Council deems it necessary to pass this Resolution as an emergency measure, effective upon passage, in order to allow for timely entry into the attached Agreement with ODNR, which will enable timely acceptance and processing of the grant funds necessary for commencement through completion of the Project, in the best interests and general welfare of the Village of Crooksville.

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

SECTION 1. Lacey Tumblin, VILLAGE ADMINISTRATOR, is hereby authorized to execute a Capital Improvement Community Park, Recreation/Conservation Project Pass-Through Grant Agreement with ODNR to provide Parks and Recreation Improvement Fund Grant funds and administration for the CROOKSVILLE WADE POOL REHABILITATION Project in the amount of \$63,700.00, all but \$1,300 retained by ODNR for administration expenses, to be used toward the cost of the CROOKSVILLE WADE POOL REHABILITATION Project, such Agreement substantially in the form attached hereto and incorporated herein.

SECTION 2. This Resolution is hereby declared an emergency measure and shall become effective upon passage, in order to allow for timely entry into the attached Capital Improvement Community Park, Recreation/Conservation Project Pass-Through Grant Agreement with ODNR, which will enable timely acceptance and processing of the grant funds and administration necessary for commencement through completion of the project, in the best interests and general welfare of the Village of Crooksville.
