ORDINANCE NO. 2522

**ORDINANCE AMENDING ORDINANCE NO. 2184 REGULATING TRASH AND
REFUSE COLLECTION IN THE VILLAGE OF CROOKSVILLE,
PERRY COUNTY, OHIO,
AND DECLARING AN EMERGENCY**

Whereas, pursuant to Ohio Revised Code § 715.43, any municipal corporation may provide for the collection and disposition of garbage and refuse;

Whereas, in accordance with Ohio Revised Code § 715.43, the Village of Crooksville previously adopted Ordinance No. 2184, enacted July 3, 1995, regulating trash and refuse collection in the Village of Crooksville;

Whereas, the Village of Crooksville previously adopted Ordinance No. 2425, enacted December 19, 2011, amending Ordinance No. 2184, but amending said Ordinance only to the extent of increasing the permit application and renewal fee; and

Whereas, the Village of Crooksville adopted Ordinance No. 2457, enacted April 15, 2013, amending the above-referenced Ordinances only to the extent necessary to revise and institute a new allowable schedule for residential and commercial trash pick-up within the Village; and

Whereas, the Village Council now desires to amend Ordinance Nos. 2184, 2425, and 2457 only to the extent necessary to revise and institute new and/or additional requirements for insurance coverage for persons, firms, companies or corporations that make application for and/or hold a permit for trash and refuse collection in the Village of Crooksville; and

Whereas, in order to protect the welfare and best interests of the Village of Crooksville and its inhabitants, this measure should pass as an emergency.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village of Crooksville, Perry County, State of Ohio, that:

Section 1. Paragraph 4.C. of Ordinance 2184 is hereby AMENDED and replaced with the following provision:

- C. The name and address of the applicant's insurance carrier and the amount of liability for injury to persons and property which amount shall not be less than \$1,000,000.00 for each occurrence.

Section 2. Paragraph 4 of Ordinance 2184 is hereby AMENDED to add the following provision:

- D. An applicant's insurance policy shall name the Village of Crooksville as an additional insured upon the applicant's policy throughout the term of the permit, and the applicant shall be required to furnish proof of compliance at the time of application, as well as at any time proof of compliance may be requested by the Village of Crooksville thereafter. An applicant's insurer must agree to and confirm in writing that the Village of Crooksville will be notified of any change to the applicant's policy. If an insurer's Certificate of Insurance or Policy contains any disclaimer or limitation on the extension of the policy's coverage to the Village of Crooksville as an additional insured, an applicant shall take whatever steps are necessary with its insurer to give effect to the extension of the policy's coverage to the Village of Crooksville, whether by the issuance of an Endorsement Certificate, removal of disclaimer, or other necessary action.

Section 3. This amendment shall affect only the paragraph and section noted, and shall not affect any other portion of Ordinance No. 2184, or its previously amending ordinances, Ordinance No. 2425 and 2457, as a whole.

Section 4. This Ordinance is hereby declared an emergency in order to protect and serve the best interests and general welfare of the Village of Crooksville, and shall therefore have immediate effect.
