ORDINANCE No. 252B

**ORDINANCE DECLARING CERTAIN PROPERTY SURPLUS  
AND AUTHORIZING ITS SALE**

**Whereas**, Ohio Revised Code § 721.15 provides for an expeditious procedure for municipalities to sell surplus personal property; and

**Whereas**, the Village of Crooksville owns a 1995 Ford Dump Truck with Air Brakes, with an approximate mileage of 98,823, valued at approximately \$5,500.00, and a 1991 Ford F-450 Dump Truck, with an approximate mileage of 46,457, valued at approximately \$5,000.00, each of which pieces of equipment is no longer needed for Village purposes and is therefore surplus personal property; and

**Whereas**, the officer or employee having supervision or management of the above-referenced property has recommended and approved its declaration as surplus;

**Whereas**, the Village of Crooksville wishes to place said equipment for sale.

**NOW THEREFORE**, a majority of the members of the Council of the Village of Crooksville, Perry County, Ohio, concurring therein, **BE IT, THEREFORE, RESOLVED:**

**Section 1:** That the Village of Crooksville hereby declares that its 1995 Ford Dump Truck with Air Brakes, with an approximate mileage of 98,823, valued at approximately \$5,500.00, and its 1991 Ford F-450 Dump Truck, with an approximate mileage of 46,457, valued at approximately \$5,000.00, are no longer needed for Village/public purpose and are therefore declared surplus personal property.

**Section 2:** That in accordance with the provisions of Ohio Revised Code § 721.15, the Council authorizes and directs the Village Administrator to place said surplus personal property items for sale. The Village Administrator may place said items for sale online with GovDeals in accordance with the Ordinance and provisions therein previously established by this Council, or may place said items for sale by regular newspaper advertisement for bid. In the event the Village Administrator chooses to place said items for sale by regular newspaper advertisement, the Village Administrator shall publish, in a newspaper of general circulation in the Village of Crooksville, notice of the Village's intent to sale the above-referenced surplus items. The notice shall include a summary description of the items declared surplus, and shall be published at least twice. The second and any subsequent notice shall be published not less than ten nor more than twenty days after the previous notice. A similar notice shall also be posted in the regular posting places for the Village of Crooksville. In any of the aforementioned sale notices, the Village Administrator shall note the following minimum bids for the personal property:

- 1995 Ford Dump Truck with Air Brakes, approximate mileage of 98,823: \$5,500.00; and
- 1991 Ford F-450 Dump Truck, approximate mileage of 46,457: \$5,000.00.


**Section 3:** That this Ordinance is effective at the earliest date allowed by law.
