

ORDINANCE NO. 2539

AN ORDINANCE ADOPTING AN ANTI-DISPLACEMENT AND RELOCATION ASSISTANCE PLAN FOR THE VILLAGE OF CROOKSVILLE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Crooksville plans to seek funding from the Ohio Development Services Agency to replace water lines, water storage tanks and to upgrade water meters for the Village of Crooksville area; and

WHEREAS, the Ohio Development Services Agency regulations require that all grantees have an Anti-Displacement and Relocation Assistance Plan.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Crooksville, Ohio as follows:

Section 1: The Anti-Displacement and Relocation Assistance Plan attached hereto and incorporated as if fully rewritten herein is hereby adopted, and should any of the planned upgrade activities involving the construction/replacement of the water line and storage tank replacement and the meter upgrade include demolition or conversion of low income housing units, the adopted plan will be adhered to; and


Section 2: This ordinance is declared to be an emergency measure to immediately place in effect the Anti-Displacement and Relocation Assistance Plan that is required per Ohio Development Services Agency regulations in order that sufficient time for timely submission of a necessary grant application may be made in order to serve the general health, safety, and welfare of the citizens of the Village of Crooksville;

Section 3: This ordinance shall take effect and be in full force upon final passage.

ANTI-DISPLACEMENT AND RELOCATION ASSISTANCE FOR LOCAL GOVERNMENTS

An Anti-Displacement and Relocation Assistance Plan is required by all grantees prior to funding, whether or not demolition activities are planned. This Table can serve as your plan if you have not previously adopted a plan. If you have previously adopted a plan, you may submit an executed copy of that plan in lieu of completing this Table (if your activities include demolition, you will need to get clearance from this office prior to proceeding with any demolition related contract that would create the need for one-for-one replacement.)

The effective date of this plan and certification is September 8, 2015.

The Village of Crooksville, Perry County, Ohio will replace all occupied and vacant occupiable low- and moderate-income dwelling units demolished or converted to a use other than low- and moderate-income housing as a direct result of activities assisted with funds provided under the Housing and Community Development Act of 1974, as amended, and as described in 24 CFR 570.488. HUD regulations have extended this requirement to the HOME program as well.

All replacement housing will be provided within three years of the commencement of the demolition or rehabilitation relating to conversion. Before obligating or expending funds that will directly result in such demolition or conversion, the Village of Crooksville, Perry County, Ohio will make public and submit to the Office of Community Development (OCD) the following information in writing:

1. A description of the proposed assisted activity;
2. The location of each site on a map and the number of dwelling units by bedroom size that will be demolished or converted to a use other than as low- and moderate-income dwelling units as a direct result of the assisted activity;
3. A time schedule for the commencement and completion of the demolition or conversion;
4. The general location on a map and approximate number of dwelling units by bedroom size that will be provided as replacement dwelling units;
5. The source of funding and a time schedule for the provision of replacement dwelling units;
6. The basis for concluding that each replacement dwelling unit will remain a low- and moderate-income unit for at least 10 years for the date of initial occupancy;
7. An analysis determining whether a dwelling unit proposed to be demolished is occupiable or not; and
8. An analysis determining whether a dwelling unit proposed to be demolished or converted is considered a low- and moderate-income unit.

The Village of Crooksville, Perry County, Ohio will provide relocation assistance, as described in 24 CFR 570.488, to each low- and moderate-income household displaced by the demolition of housing or conversion of a low- and moderate-income dwelling to another use as a direct result of assisted activities.

Consistent with the goals and objectives under the Act, the Village of Crooksville, Perry County, Ohio agrees to provide substantial levels of assistance to persons displaced by HUD-assisted programs and will further seek to minimize displacement of persons as a result of assisted activities.
