ORDINANCE NO. 2565

AN ORDINANCE TO AMEND ORDINANCE NO. 2553 OF THE ORDINANCES OF THE VILLAGE OF CROOKSVILLE APPROVING, ADOPTING AND ENACTING AMERICAN LEGAL PUBLISHING'S OHIO BASIC CODE, 2016 EDITION, AS THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF THE VILLAGE OF CROOKSVILLE

Whereas, on March 7, 2016, the Council of the Village of Crooksville adopted Ordinance 2553, an Ordinance Approving, Adopting and Enacting certain chapters and provisions of American Legal Publishing's Ohio Basic Code, 2016 Edition, as the Code of Ordinances for the Municipality of the Village of Crooksville; and

Whereas, Ohio Revised Code Section 723.01 provides that a municipal corporation shall have special power to regulate the use of the streets; and

Whereas, American Legal Publishing's Ohio Basic Code, 2016 Edition, in its Chapter 94, incorporates provisions in accordance with Ohio Revised Code Section 723.01 that will benefit the Village of Crooksville; and

Whereas, it is in the interest of the peace, health, safety, welfare and effective administration of the Village that said Basic Code Ordinance is amended to the extent necessary to further include in those provisions approved, adopted and enacted with the Village of Crooksville the following: Chapter 94: Streets and Sidewalks, General Provisions, Sections 94.01 through 94.06, and Section 94.99.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village of Crooksville, Perry County, State of Ohio, that:

1. Ordinance 2553 is hereby amended ONLY to the following extent: the following provisions of the 2016 Ohio Basic Code shall be INCLUDED within Sections One and Three and are hereby approved, adopted and enacted within the Village of Crooksville:

Chapter 94: Streets and Sidewalks

General Provisions

§ 94.01 Conditions Precedent to Improving Streets

§ 94.02 Opening Permit Required

§ 94.03 Application and Cash Deposit

§ 94.04 Restoration of Pavement

- § 94.05 Barriers and Excavations
- § 94.06 Warning Lights
- § 94.99 Penalty.
- 2. This amending ordinance shall affect only the sections as noted, and shall not affect any other portion of Ordinance No. 2553 as a whole.
- 3. This Ordinance shall take effect at the earliest date allowed by law.
