

**ORDINANCE NUMBER 2604, AN ORDINANCE TO APPLY FOR AN AMENDED CERTIFICATE AND OR AMENDING THE ANNUAL BUDGET ORDINANCE NUMBER 2560 FOR 2017 AND DECLARING IT AN EMERGENCY.**
