

**RESOLUTION TO TENTATIVELY AWARD CONSTRUCTION CONTRACTS FOR
THE WATER SYSTEM IMPROVEMENTS PROJECT
AND DECLARING AN EMERGENCY**

WHEREAS, the Village of Crooksville wishes to construct improvements to its existing water system;
and

WHEREAS, on June 5, 2017 bids were received for the Water System Improvements project; and

WHEREAS, the Council wishes to tentatively award the two contracts to the recommended best bidders, contingent upon receipt of an Ohio EPA WSRLA loan approval; and

WHEREAS, said recommended best bid for Contract #1 – Waterline Replacement is Freedom Construction Enterprises, Inc. in the amount of Four Million, One Hundred One Thousand, Seven Hundred Forty-Nine and 00/100 Dollars (\$4,101,749.00) and said recommended best bid for Contract #2 – Water Storage Tank is Mid-Atlantic Storage Systems, Inc. in the amount of Three Hundred, Nineteen Thousand, Eight Hundred Sixty-Four and 00/100 Dollars (\$319,864.00).

WHEREAS, the Engineer, Jobes Henderson and Associates, has recommended awarding the bids as detailed above; and

WHEREAS, the Mayor shall be authorized to execute the Notice of Award and the Agreement for the Construction Contract as funds are secured, now

BE IT RESOLVED, that the Village Council of Crooksville, Ohio:

SECTION 1. Award for construction of the proposed Water System Improvements project, Contract #1 – Waterline Replacement to Freedom Construction Enterprises, Inc., for a contract amount of \$4,101,749.00 and Contract #2 – Water Storage Tank to Mid-Atlantic Storage Systems, Inc. for a contract amount of \$319,864.00; award contingent upon Ohio EPA’s concurrence with the award and the availability of funding.

SECTION 2. The Mayor is hereby authorized to sign all documents for and enter into an agreement for the said contract for the construction of the Water System Improvements on behalf of the Village Council of Crooksville.

SECTION 3: This Resolution shall pass as an emergency and have immediate effect, in the interests of the public welfare, in order that no delay shall be caused to the improvements planned for the Village’s Water System Improvement Project.




