A RESOLUTION AUTHORIZING THE MAYOR OF THE VILLAGE OF CROOKSVILLE TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER POLLUTION CONTROL LOAN FUND AGREEMENT FOR A PLANNING LOAN TO COMPLETE A STORM WATER UTILITY FEASIBILITY STUDY; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN:

Whereas, the Village of Crooksville, Perry County, Ohio is considering creating a storm water utility to address lack of infrastructure for storm and clean water conveyance away from Village streets; and

Whereas, the Village of Crooksville intends to apply for a Water Pollution Control Loan Fund (WPCLF) for funding to complete a feasibility study for the storm water utility; and

Whereas, the Ohio Water Pollution Loan Control Fund requires the government authority to pass legislation authorizing application for a loan and the execution of an agreement, as well as designating a dedicated repayment source for the loan;

NOW THEREFORE, a majority of the members of the Council of the Village of Crooksville, Perry County, Ohio, concurring therein, **BE IT, THEREFORE, RESOLVED**:

SECTION 1. That the Mayor is hereby authorized to apply for a WPCLF loan, to sign all documents for and enter into a Water Pollution Control Loan Fund with Ohio Environmental Protection Agency and the Ohio Water Development Authority, for a planning loan to complete a storm water utility feasibility study on behalf of the Village of Crooksville, Ohio.

SECTION 2. That the dedicated source of repayment will be user fees charged for the storm water utility and/or the general fund.

SECTION 3. That this Resolution shall have effect upon its passage at the earliest date allowable by law.
