AND DECLARING EMERGENCY

Whereas, the Village of Crooksville has acted in accordance with the Resolutions and Ordinances of this Village and the laws of the State of Ohio in abating nuisances within the Village of Crooksville;

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED:


1. This Council finds that the Village has abated a certain nuisance, after notifying the owner of the property on which such nuisance originated, and has reported the cost of such abatement, all as provided by law, as follows:


2. The amount above shown is hereby assessed on the property shown, and such assessment shall be certified for collection on the 2018 tax year duplicate in the same manner as general taxes.
3. Emergency Clause: This resolution is hereby declared an emergency measure necessary for the immediate preservation of the peace, health, safety and welfare of the Village of Crooksville and the members thereof, and for the purpose of paying the expenses of conducting and managing the Village operations and reimbursing the Village funds from which the contractor was paid for the nuisance debris removal which threatened the public safety, and for the efficient and timely submission of assessments to the County Auditor for certification for collection on the earliest possible tax year duplicate. Therefore, this Resolution shall go into immediate effect upon its passage.






