## 10-03-2016 Council Minutes

Crooksville Council Meeting Minutes, Monday, October 3, 2016

**ROLL CALL**: Mayor Redfern called the meeting to order with the following members present Mr. Locke, Mr. Hampton, Ms. Smith, Ms. Driggs, and Mr. Mohler. Tom Collins and Jan Baughman were present. Chris Rice was absent.
