Council Workshop Minutes Monday, September 14, 2015

Chris Mohler called the meeting to order. Present were Fred Redfern, Bill Hampton, Billie Smith, and Jan Driggs. Tom Collins was present. Mayor Lantz and Chris Rice were absent.

- 1. Brittany stated that first on her agenda was the Fund Summary Report with most bills paid, all transfers completed and revenue entered through the end of the day.

- 3. The last item on his agenda was to discuss Shriver's Pharmacy and their request to use the Rec Center parking lot for the grand opening. Council was good with this.
- 4. The only thing left was to go into executive session per ORC 122.21 (G) (2) Sale or purchase of Property and would like to invite Police Chief Walters in to discuss a purchase issue.

Chris Mohler informed Council that there was a notice from the Perry County Health Department on wastewater treatment plant that they are proposing to build for the area of six mile turn.
