ORDINANCE NO. 2644

**ORDINANCE ESTABLISHING  
THE STORMWATER UTILITY PROGRAM ENTERPRISE FUND**

**Whereas**, the Village of Crooksville, by Ordinance No. 2588 did establish a Stormwater Drainage Utility together with Just and Equitable Charges for Stormwater Drainage Utility Users; and

**Whereas**, Section 5 of said Ordinance provides for the deposit of all service charges and all sources of revenue generated by or on behalf of the stormwater utility into a stormwater utility enterprise fund for use exclusively for the purpose of stormwater utility; and

**Whereas**, the Village of Crooksville is in need of a separate fund within its accounting practices and systems that will be utilized as directed by Section 5 of Ordinance No. 2588.

**NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED** by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

**Section 1.** A separate and specific fund is hereby established within the accounting practices and systems of the Village of Crooksville that will be utilized as a utility enterprise fund for the specific purpose of receiving and accumulating all service charges and all sources of revenue generated by or on behalf of the Village's stormwater utility and for paying monies therefrom exclusively for the purposes of the stormwater utility, as set forth in Ordinance No. 2588. Said fund shall be known as the Stormwater Utility Program Enterprise Fund.

**Section 2.** Unless otherwise an emergency and allowable by law, expenditures from said Stormwater Utility Program Enterprise Fund shall be for stormwater utility purposes only.

**Section 3.** This ordinance is hereby declared an emergency measure necessary to the immediate preservation of the welfare and sound accounting practices of the Village of Crooksville and residents thereof, and for the efficient and timely management of the storm water utility charges that are being collected and accumulating in accordance with the passage of Ordinance No. 2588, as of January 1, 2019. Therefore, this ordinance shall go into immediate effect upon its passage, and shall have retroactive application to January 1, 2019.


