## Crooksville Council Meeting Minutes Monday, March 2<sup>nd</sup>, 2020

**ROLL CALL**: Mayor Mohler called the meeting to order with the following members present: Mr. Rice, Mr. Locke, Mr. Hampton, Ms. Smith, Mr. Allen. Mr. Loomis was absent. Jan Baughman, Amy Utsch, and Tom Collins were also present.

**MINUTES:** Motion to approve Clerk's Minutes was made by Mr. Rice and seconded by Mr. Hampton. Motion carried.

**PAID BILLS**: A motion to approve Resolution 2020-20 paid bills and payroll was made by Mr. Allen and seconded by Mr. Locke. Motion carried.

**TO BE PAID BILLS**: A motion to approve Resolution 2020-21 to be paid bills was made by Mr. Rice, and seconded by Mr. Hampton. Motion carried.

**TRANSFER**: A motion to approve Resolution 2020-22 transferring funds was made by Mr. Rice, and seconded by Ms. Smith. Motion carried.

**SERVICE:** A motion is needed to approve an additional Trash Hauling Service for Crooksville. Fees have been paid and insurance received by Kimble Trash. This will be taking over for Waste Away Trash Service. Motion is made by Mr. Rice, and seconded by Mr. Allen.

**LEGISLATIVE:** A Motion is needed to approve the third reading of Ordinance 2671, an Ordinance to amend Ordinance 2455, of the Ordinances of the Village of Crooksville fixing and establishing Water and Sewer Rates to waive 2020 water/Sewer rate increase. Motion is made by Mr. Rice, and seconded by Mr. Ms. Smith. Motion is Accept Ordinance 2671 is made by Mr. Rice, and Seconded by Ms. Smith. Motion Carried.

**CEMETERY BOARD**: The Cemetery Board closed out 2019 with a balance of \$180,189.19.
