

ROLL CALL: Mayor Chris Mohler calls the meeting to order with the following members being present; Mr. Rice, Mr. Hampton, Ms. Smith, Mr. Allen, and Mr. Loomis. Tom Collins and Jan Baughman were also present. Mr. Locke was absent.

MINUTES: Motion to approve Clerk's Minutes was made by Mr. Rice, and seconded by Mr. Hampton. Motion Carried.

SOLICITOR'S LIST: Jan sent out an Emergency Ordinance to be reviewed. They will have to look into it further and review before a discussion and a decision can be made.

FINANCE: RESOLUTION 2020-28 Payroll paid. Motion made by Mr. Rice, and Seconded by Mr. Allen. Motion carried.

RESOLUTION 2020-26 Transfer of funds and Supplemental Appropriations. Motion made by Mr. Rice, and Seconded by Mr. Allen. Motion Carried.

RESOLUTION 2020-27 Accounting invoices paid. Motion made by Mr. Hampton, and seconded by Mr. Loomis. Motion carried.

OLD BUSINESS: A motion is needed to correct March 16th Council meeting minutes: Marilyn Horner's probationary period is SIX (6) Months, not the TWELVE (12) months as read in the meeting. The motion is made by Mr. Rice, and seconded by Mr. Loomis. Motion carried.

NEW BUSINESS: A motion is needed to approve Pay request #2 for Tucson Excavating in the amount of \$90,000. Motion is made by Mr. Rice and seconded by Mr. Hampton. Motion carried.

A motion is needed to approve Brandon Forrester's demolition permit for 237 Vaughn Street. Motion is made by Mr. Rice and seconded by Mr. Hampton. Motion Carried.

EXECUTIE SESSION: Motion is to enter into Executive session ORC 122. (G)(2) Real-estate, by Mr. Rice, and Seconded by Mr. Hampton.

Out of Executive Session

Motion to approve App Architecture's proposal for Design Development through Construction Administration for the new Fire/EMS facility in the amount of \$135,966. Additional cost items are \$6,900 for the tornado shelter, and \$1,500 for reimbursable expenses. Motion is made by Mr. Rice, and seconded by Mr. Hampton. Motion Carried.

Ralph Hill is present to discuss the COVID-19 situation. As of now there are 4 Confirmed cases in Perry, 1 in Morgan, and 9 in Muskingum County. The Perry County Health Department is hoping to soon be able to offer a Drive Thru testing. Ralph lets Council know that as of right now the Fire/EMS is OK on supplies. He ordered supplies approximately a month ago, and they are slowly one by one beginning to trickle in. Harbor Freight was generous enough to donate coveralls. If they run out of masks, they have enough respirators for the staff. Some of the steps that are being taken are if you test positive for the COVID-19, anyone you have been in contact with over the prior 14 days is notified, and should self-quarantine. People can be a carrier of the virus, without showing any of the symptoms, meanwhile

passing it on to people they have been in contact with. People are told to stay home. There are to be no more than 10 people to a gathering, and social distancing of at least 6 feet is recommended to reduce the spread. Rodney Walters is in self-quarantine until the test results of his son (who showed some symptoms) are in, and everyone is in the clear.

Jon Allen has received many complaints regarding junk vehicles throughout the Village. He is curious as to if Jerry is still working during this time, and if we plan on continuing to enforce the Junk Vehicle Ordinance. Jerry is still working his typical hours, but at this time there are no community service workers working.

Rocky Chevalier spent some time riding with Rodney Walters, and is curious as to what the Ordinance states regarding house numbers being displayed on the houses. He requests a copy of the ordinance be sent to him. He feels that this is important to help Emergency Responders to quickly find the correct locations, as to the fact that GPS is not always a reliable source. It is stated that the house numbers should be at least 3 inches tall, and it is beneficial if they are reflective as to be seen better at night; even though that is not a requirement.

With no further discussion Mayor Mohler calls the motion to adjourn the meeting. Motion is made by Mr. Hampton and Mr. Rice. Motion Carried. Meeting Adjourned.
