FINANCE: Motions are needed for the following Resolutions:

Is there a motion to add the ambulance at replacement costs for an added premium of \$487? A motion is made by Mr. Rice, and seconded by Mr. Loomis. Motion carried.

NEW BUSINESS: Are we interested in biding on the Massey Ferguson boom mower on GovDeals? The auction ends tomorrow at 3:00 p.m. The motion to bid on the boom mower was made by Mr. Rice, and seconded by Mr. Allen. Motion carried.

EXECUTIVE SESSION: Mr. Hampton makes the motion to go into Executive Session per ORC 121.22(G)(3) for Real Estate, and Mr. Allen seconds the motion. Out of Executive Session with no decisions being made.

ADJOURNMENT: Without any further discussion Mr. Rice makes the motion to adjourn, and Mr. Allen seconds the motion. Motion carried. Meeting adjourned.
