OLD BUSINESS: Mr. Allen makes a motion to cease negotiation with the school in giving them ownership of the football field. Mr. Locke seconds.

It needs two thirds vote to pass, but Mr. Hampton and Mr. Rice will abstain so council wants to get the legal advice needed in this case and if the 3 votes would be enough. Mr. Allen made the motion to cease and desist because the school pays park and pool levy taxes and he doesn't think the six of them have the right to give away the football field.

NEW BUSINESS: A motion is needed to hire Brandi Holsky to clean the park restrooms at \$12/hr as a contract employee. A motion is made by Mr. Allen, and seconded by Mr. Locke.

Lee Murphy is concerned about the football field and what's going to happen with it. The school cannot secure grants with only leasing the field, which is why they are wanting to purchase it. They don't want to put money into something when its not fully theirs. Council has some concerns about the legal parts of it. If they sell to the school and then a private school wanted to build on it, they could sell it to them instead of back to the village. A joint recreational association between the school and the village was never looked into. No one from the school board has met and talked with council since the first time they brought this up, nor shared any plans. The school wants an easement in from China Street to the entrance of the football field. Another easement in from the septic tank in front of the maintenance garage to the entrance of the football field. They wanted 60ft out from the fence to build a shower house. They since have revised that to 30ft. They want a 5ft easement all the way around the perimeter of the fence. Council all agrees they would love to see the school play there but do not like that they would have no decision making from the village. It should be a mutual thing. Council is worried that later on down the road if something happens and they sell or lose the field then it will never be property of the Village again. If it's going to be done, they want it done right. Without knowing more legal sides of it, it will not be passed.


