Workshop Minutes

September 27<sup>th</sup>, 2021

Mayor Mohler calls the meeting to order with the following members present; Mr. Rice, Mr. Locke, Mr. Hampton, Ms. Smith, Mr. Allen, and Mr. Loomis. Tom Collins and Lacey Tumblin was also present.

First up is a special meeting following by the regular workshop meeting. A motion is needed to accept Kyle Calendine's resignation effective 9/21/21. A motion is made by Mr. Rice, and seconded by Ms. Smith.

First up on the agenda, the easements for Cherry Lane are ready and just need signatures. Both the Fire/EMS Station and the Neighborhood Revitalization Grant are now completed. Per the 2020 Census, the population of the Village is 2,418. AEP wants us to sign an updated lease and they will send us a check for \$3,000.

Next up is discussion on Covid pay. After talking to New Lex, Somerset, and New Concord they are all requiring employees to use any sick or comp time they may have otherwise they aren't getting paid for being off for Covid. We will do the same. Roseville is doing Trick or Treat on Thursday the 28<sup>th</sup>, we will be matching ours with them. It will be from 6:00 to 7:30.

Council discuss what they want to see done with the Coronavirus State and Local Fiscal Recovery Funds from the American Rescue Plan Act. The categories it must fall under are: Public health and economic impacts, premium pay, revenue loss, and investments into water, sewer, storm, or broadband infrastructure. Council discuss some new upcoming Christmas decorations. They are wanting to use about \$3,000 to add another feature at the park this year. Everyone agrees that they would love to see even more people getting involved in decorating the town this year.

Chief Bryan talks about his chief training last week. Perry County is currently #2 in the state for Covid numbers.

Council goes into Executive Session per ORC 121.22 (G) (1) to discuss Personnel Employment and per ORC 121.22 (G) (2) to consider the purchase of property for public purposes.
