

RESOLUTION No. 2020-7

**RESOLUTION AUTHORIZING A MUTUAL AID AGREEMENT
WITH THE VILLAGE OF ROSEVILLE, FOR POLICE PROTECTION
FOR THE YEAR 2020 AND DECLARING AN EMERGENCY**

Whereas, the Village of Crooksville is a political subdivision of the State of Ohio and is duly organized and existing pursuant to the Constitution and the laws of the State of Ohio;

Whereas, pursuant to Ohio Revised Code § 737.04, the governing body of the Village of Crooksville ("Council") is authorized to enter into contracts with one or more municipal corporations, upon any terms that are agreed upon, for services of police departments or for the interchange of services of police departments, in order to obtain police protection or additional police protection or to allow its officers to work in multijurisdictional task forces;

Whereas, the Council hereby finds and determines that the execution of a Mutual Aid Agreement with the Village of Roseville for obtaining from Roseville additional police protection, providing for Roseville additional police protection, and to allow Crooksville's police officers to work in multijurisdictional task forces for the benefit of Roseville and/or Crooksville is appropriate and necessary to the functions and operations of the Village of Crooksville, and its Police Department.

NOW THEREFORE, a majority of the members of the Village of Crooksville, Perry County, Ohio, concurring therein, **BE IT, THEREFORE, RESOLVED**:

§ 1. The Village Mayor and the Village Chief of Police (each an authorized representative) acting on behalf of the Village of Crooksville, are hereby authorized to negotiate, enter into, execute and deliver a Mutual Aid Agreement in substantially the form set forth in the document presently before the Council, which document is attached hereto and incorporated herein by reference, and is available for public inspection at the office of the Village of Crooksville. Each authorized representative acting on behalf of the Village is hereby authorized to negotiate, enter into, execute and deliver such other documents relating to the Mutual Aid Agreement as the authorized representative deems necessary and appropriate. All other related contracts and agreements necessary and incidental to the Mutual Aid Agreement are hereby authorized.


§2. The effective period of this Mutual Aid Agreement shall be January 1, 2020, through December 31, 2020. The Village of Crooksville's obligations under the Mutual Aid Agreement shall be subject to annual renewal by the Council, as set forth in the Agreement.

§3. Emergency Clause: This resolution is hereby declared an emergency measure necessary for the immediate preservation of the peace, health, safety and welfare of the Village

of Crooksville and the members thereof, and for the efficient and timely continuation of the mutual aid services to which the Villages of Crooksville and Roseville are accustomed and which are necessary to the safety of the respective Villages' inhabitants. Therefore, this Resolution shall go into immediate effect upon its passage.


