## **ORDINANCE NO. 2714**

AN ORDINANCE AUTHORIZING AND DIRECTING THE VILLAGE OF CROOKSVILLE MAYOR TO ENTER INTO AN AGREEMENT WITH THE REGIONAL INCOME TAX AGENCY FOR THE ADMINISTRATION OF THE INCOME TAX LAWS OF THE VILLAGE OF CROOKSVILLE AND FOR THE COLLECTION OF SAID INCOME TAXES IN THE VILLAGE OF CROOKSVILLE, AND DECLARING AN EMERGENCY

WHEREAS, a Regional Council of Governments was created pursuant to Chapter 167 of the Ohio Revised Code to foster cooperation between Ohio's political subdivisions; and

WHEREAS, the creation of the Regional Council of Governments was primarily to establish a central collection facility (the Regional Income Tax Agency) for the administration of the income tax laws and the collection of said income taxes of the various participating member political subdivisions; and

WHEREAS, the Village Council of the Village of Crooksville finds it to be in the best interests of the health, safety, and welfare of the Village of Crooksville to join the Regional Council of Governments for the purpose of having the Regional Income Tax Agency administer the Village of Crooksville's income tax laws and collect said income taxes of the Village of Crooksville; and

WHEREAS, the Village Council of the Village of Crooksville desires the Village Mayor to enter into an agreement with the Regional Income Tax Agency to administer the Village of Crooksville's income tax laws and collect said income taxes of the Village of Crooksville.

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

**SECTION 1.** The Village of Crooksville Mayor is hereby directed and authorized to enter into an agreement with the Regional Income Tax Agency on behalf of the Village of Crooksville for the administration of the Village's income tax laws and collection of said income taxes of the Village of Crooksville.

**SECTION 2.** The Village of Crooksville Income Tax Administrator is hereby appointed as representative to the Regional Council of Governments and the Village of Crooksville Fiscal Officer is hereby approved as alternate to the Regional Council of Governments.

**SECTION 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in full compliance with all legal requirements, including without limitation, those set forth in Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be a measure necessary for the immediate preservation of the public peace, health, and safety and welfare of the inhabitants of the Village of Crooksville, and requires immediate passage by the Village Council of the Village

of Crooksville to allow for the Village of Crooksville's smooth transition into its participation and membership in the Regional Income Tax Agency in a timely manner in order to continue the necessary daily operations of the Village of Crooksville's Income Tax Division and Income Tax Administrator.
