Ms. Smith asked about a light being put back in where the new bridge was just completed. Mayor Mohler stated that they would need to get ahold of AEP to replace those.

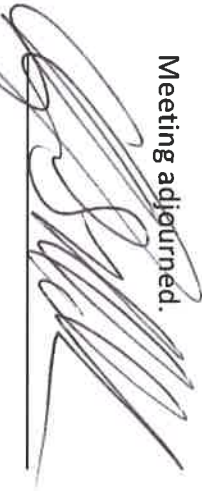
**NEW BUSINESS:** Mrs. Tumblin stated that they will have a special meeting before Workshop next Monday, 09/12/22, regarding the Budget.
