

Village of Crooksville
Council Workshop Meeting
July 24, 2023

Mayor Mohler calls the meeting to order with the following Council members present: Mr. Hampton, Mr. Locke, Mr. Loomis, Mr. Redfern, Ms. Smith and Mr. Walters. Lacey Tumblin and Courtney Edwards were also present.

First up on the agenda, Daniel McBane from McBane Insurance, was present to discuss the Property and Casualty Liability proposal for the upcoming year.

Next, Daryl Newlon was present to speak about the tool mounts that came in and waiting on another quote to get the battery charges installed. He stated that he has one quote but that it is high for what they need done.

He also wanted to discuss the stop sign on Sand St. in front of the church. He stated that it is too far up the street and that a car over the weekend hit another car.

Next up, Michelle Love was present to speak to the Council. She introduced herself and would like to work on EMS and get her Fire card as well. She currently works for Roseville Fire Department as basic EMT. The council stated they will get her on the agenda for 2 weeks.

Next, Chief Alexander discussed a grant for radios and cameras. He stated that Heidi Milner's rate is \$1000 to write the grant and 10% if it is approved.

Mrs. Tumblin brought an application for a building permit for a fence on 411 E. Main St. She stated that she wanted to get an unofficial approval since Heather Chapman was out on Monday, we didn't have all the information back from guys. The council all agreed to approval and will get it on the agenda for official approval in 2 weeks.

Mrs. Tumblin wanted to update the Council on installing new pit meters and house meters. She stated that we have only 30 pit meters and 71 house meters left in install.

Mrs. Tumblin has the application submitted to Mid-East for the salt bin and is scheduled to start mid-August.

Next Ms. Tumblin stated that the following day there is to be a zoom meeting with ODOT regarding the Buckeye St. bridge project.

Insurance had asked for the agreements for the usage of the Village Properties. Mrs. Tumblin passed out the agreements that Mrs. Baughman and her staff have been working on.

Mr. Redfern stated that a woman approached him about using the Rec Center for her county wide softball league. Mrs. Tumblin stated that she could call Heather and see what is available.

Next up, Mrs. Tumblin stated that she was made aware that the Pool does not have any handicapped signs for parking. The council agreed that we could get 2 signs. They discussed possibly paving the handicapped area down the road.

Mayor Mohler wanted to check on the sign for Rodney C. Wilson sign for South Park. Mrs. Tumblin stated it was ordered and she would call on the status.

It was discussed 2 weeks ago to get on the ballet for fall regarding full time Police Officer wages. Mayor Mohler just wanted to touch base with Council on the numbers he received from Drew.

Next, Mr. Redfern stated he was given a 911 sign from the Health Department. He wanted to know where the council wanted him to put it. It only has the number 7 on it. The council feels that it should have more information than the number seven. They feel if it were to say 7 Park Dr people would understand what the 7 means. Mr. Redfern said that he would bring the sign to Lacey to see what they wanted to do with it.

Council went into Executive Session 121.22 (G)(1).

Out of Executive Session.

Next up, Mrs. Tumblin stated that she has reached out to 18 different pool companies for quotes on the baby pool. Three companies said "NO", one said they would get a quote and she hasn't heard anything back from anyone else. She also stated that Tim Bobb spoke to a guy that is local and he went and looked at the pool and wanted the blueprints for the pool if anyone knew where those might be.

Mrs. Tumblin said we will also have a quote on getting the press box taken down at the old football field from Matt Headley.
