## RESOLUTION AUTHORIZING ACCEPTANCE OF OHIO DEPARTMENT OF TRANSPORTATION (ODOT) GRANT FOR BUCKEYE STREET BRIDGE REPLACEMENT PROJECT (SFN 6461212)

WHEREAS, the Village of Crooksville made application for a grant through the Ohio Department of Transportation (ODOT) for funding in the Municipal Bridge Program; and

WHEREAS, via letter dated May 31, 2023, the Village of Crooksville was notified by ODOT that its' Buckeye Street Bridge Replacement Project (SFN 6461212) has been selected for funding in the Municipal Bridge Program, in the amount of 100% of eligible construction and engineering costs, up to a maximum of \$872,166 in Federal Funds in State Fiscal Year (SFY) 2026; and

WHEREAS, written acceptance is required on or before Friday, July 14, 2023, together with additional action to make calls and commit to project dates as outlined in the grant award letter.

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

**SECTION 1.** The Village of Crooksville hereby accepts the funding grant awarded the Village by the Ohio Department of Transportation for its' Buckeye Street Bridge Replacement Project (SFN 6461212) through the Municipal Bridge Program, in the amount of 100% of eligible construction and engineering costs, up to a maximum of \$872,166 in Federal Funds in State Fiscal Year (SFY) 2026.

**SECTION 2.** The Village Administrator is instructed and authorized to take the actions necessary to implement this Resolution, including but not limited to: delivering of written acceptance of the awarded Municipal Bridge funds on or before Friday, July 14, 2023; contacting Ben Boyer at ODOT District 5 Office to schedule a project scope meeting and to start the process of programming the project; and establishing solid commitment dates for the project.

SECTION 3. This resolution is hereby declared to an emergency measure necessary for the immediate preservation of the public peace, health, and safety and welfare of the inhabitants of the Village of Crooksville and requires immediate passage to allow the timely acceptance of the grant for the much-needed replacement of the Buckeye Street bridge necessary for safe passage on a heavily travelled thoroughfare that provides a quick and necessary travel access for residents of the Village as well as for police and police vehicles, and fire and emergency responders and emergency response vehicles . This resolution shall have immediate effect upon its passage.
