RESOLUTION NO. 71-2023

**A RESOLUTION ADOPTING THE PERRY COUNTY 2023
MULTI-HAZARD MITIGATION PLAN DATED JULY 7, 2023
AND DECLARING AN EMERGENCY**

The Village Council of Crooksville met in Regular Session on the 17th day of July, 2023 at the Council Chambers with the following members present:

Mr. Redfern moved the adoption of the following Resolution:

WHEREAS, the Village of Crooksville recognizes the threat that natural hazards pose to people and property within Crooksville; and

WHEREAS, the Perry County Emergency Management Agency has prepared a multi-hazard mitigation plan, hereby known as Perry County 2023 Multi-Hazard Mitigation Plan dated July 7, 2023 in accordance with federal laws, including the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended; the National Flood Insurance Act of 1968, as amended; and the National Dam Safety Program Act, as amended; and

WHEREAS, Perry County 2023 Multi-Hazard Mitigation Plan dated July 7, 2023, identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in Crooksville from the impacts of future hazards and disasters; and

WHEREAS, adoption by the Village of Crooksville demonstrates its commitment to hazard mitigation and achieving the goals outlined in the Perry County 2023 Multi-Hazard Mitigation Plan dated July 7, 2023.

NOW THEREFORE, BE IT RESOLVED by the Village of Crooksville, Ohio, that:

SECTION 1. In accordance with Ohio Revised Code, the Village of Crooksville adopts the Perry County 2023 Multi-Hazard Mitigation Plan dated July 7, 2023. While content related to Crooksville may require revisions to meet the plan approval requirements, changes occurring after adoption will not require Village of Crooksville to re-adopt any further iterations of the plan. Subsequent plan updates following the approval period for this plan will require separate adoption resolutions.

SECTION 2. This Resolution is hereby declared an emergency measure and shall become effective upon passage, in order to allow for timely approval and implementation


of the Perry County 2023 Multi-Hazard Mitigation Plan dated July 7, 2023, in the best interests and general welfare of the Village of Crooksville.
