ORDINANCE NO. 2642

**ORDINANCE ESTABLISHING A  
SCHEDULE OF FINES FOR TRAFFIC AND OTHER CODE VIOLATIONS  
FOR THE VILLAGE OF CROOKSVILLE  
AND DECLARING AN EMERGENCY**

**Whereas**, the Village of Crooksville conducts a Mayor's Court pursuant to the Ohio Constitution and the Ohio Revised Code; and

**Whereas**, in order to provide for effective and efficient, uniform determination of appropriate fines for violations of traffic and other Code provisions within the Village of Crooksville, the Village Council has recognized the need of establishing a schedule therefore; and

**Whereas**, the Village Council desires to establish, retroactively to January 1, 2019, the schedule of appropriate fines for violations of traffic and other Code provisions that shall be imposed for 2019; and

**Whereas**, it is necessary to pass this Ordinance as an emergency measure, for the continued operations of the Mayor's Court, for good fiscal practice and for the immediate preservation of the peace, health, safety and general welfare of this Village.

**NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED** by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:


**Section 1.** Fee and Fine Schedule. The Schedule attached hereto and incorporated herein by reference shall serve as the Fee and Fine Schedule for fees and fines imposed for all traffic and other provision violations within the Village of Crooksville for 2019, January 1 through December 31. All fees and fines imposed shall be in accordance with such Schedule and the laws of the Village of Crooksville and the State of Ohio.

**Section 2.** Collection of Funds. All monies received under the provisions of this ordinance shall be placed in an account set up for the express purpose of collection of fees and fines from the Village of Crooksville Mayor's Court.

**Section 3.** This ordinance is declared an emergency measure necessary for the continued operations of the Mayor's Court, for good fiscal practice and for the immediate preservation of the peace, health, safety and general welfare of the people of this Village, and shall take effect at the earliest date provided by law.




