A RESOLUTION AUTHORIZING THE PERRY COUNTY ENGINEER TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAMS(S) AND TO EXCUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the Village of Crooksville is planning to make capital improvements in the form of Paving Village Streets; and

WHEREAS, the infrastructure improvement herein above-described is considered a priority need for the community and is a qualified project under OPWC programs; and

WHEREAS, the Village of Crooksville has sufficient funds in its Permissive Tax Fund to pay the local share, should a local share be required, for the Perry County Village of Crooksville 2021 Paving Project; and

WHEREAS, this Resolution must pass as an Emergency in order to comply with application time requirements relevant to the financial assistance.

NOW THEREFORE, BE IT RESOLVED by the Village of Crooksville:

Section 1: The Perry County Engineer is hereby authorized to apply to the OPWC for funds as described above, for the Village of Crooksville's capital improvements in the form of Paving Village Streets.

Section 2. The Perry County Engineer is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

Section 3. The Fiscal Officer is authorized to certify to the Ohio Public Works Commission that the Village of Crooksville has sufficient funds in its Permissive Tax Fund to pay the local share, should one be required, for the Perry County Village of Crooksville 2021 Paving Project.

Section 4. This Resolution is hereby declared an Emergency and shall have immediate effect on its passage in order to comply with application time requirements relevant to the financial assistance.
