ORDINANCE NO. 2692

**ORDINANCE APPROVING AND ADOPTING
THE POLICE DEPARTMENT POLICIES AND PROCEDURES MANUAL
FOR THE VILLAGE OF CROOKSVILLE, OHIO;
AND REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH.**

Whereas, the Chief of Police and the Mayor recommend the adoption of The Police Department Policies and Procedures Manual for the Village of Crooksville as presented to Council in 2018 and recently revised to address U.S. Presidential Order restricting neck restraints and choke holds.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

Section One. The Village Council approves and adopts The Police Department Policies and Procedures Manual as drafted in 2018 and amended February 3, 2021, and further amended in February 2022, in full.

Section Two. One complete copy of The Police Department Policies and Procedures Manual revised through February 21, 2022, certified as correct by the Mayor and Chief of Police of the Village, shall be kept in its initial form on file in the office of the Fiscal Officer of the Village of Crooksville and retained as a permanent ordinance record of the municipality.

Section Three. All former ordinances and resolutions or parts thereof which are in conflict or inconsistent with any provision of The Police Department Policies and Procedures Manual revised through February 21, 2022, as adopted in Section One hereof, are hereby repealed as of the effective date of this ordinance.


Section Four. This ordinance shall take effect and be in full force at the earliest date allowed by law.
