RESOLUTION NO. 32-22

RESOLUTION ESTABLISHING THE AMERICAN RESCUE PLAN LOCAL FUND, ALLOCATING ARP FUNDS RECEIVED TO REVENUE LOSS, AND ELECTING THE STANDARD ALLOWANCE AS DEFINED BY THE FINAL RULE, TO BE USED FOR GOVERNMENT SERVICES.

WHEREAS, the American Rescue Plan Act of 2021 ("ARP"), a \$1.9 trillion economic COVID-19 stimulus package, was signed into law on March 11, 2021, to provide monetary relief to address the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, the Village of Crooksville is a recipient of ARP funding as a non-entitlement unit of local government; and

WHEREAS, the Final Rule issued by the U.S. Department of the Treasury on January 7, 2022, provides that recipients including the Village of Crooksville can elect to use a Standard Allowance for revenue loss of up to ten million dollars, allowing the funds to be used for the provision of government services; and

WHEREAS, pursuant to Resolutions 29-22 and 30-22, the Village Council previously established the ARP Local Fund, to account for revenues and expenditures related to the funds received by the Village of Crooksville through the American Rescue Plan Act of 2021; and

WHEREAS, in said Resolutions 29-22 and 30-22, the Village Council provided further for allocation of all funds received pursuant to the American Rescue Plan Act of 2021 which were not previously allocated by the Village Council to revenue loss and elected the Standard Allowance as defined by the Final Rule, and provided further that all ARP funds received not previously allocated by the Village Council are to be expended for the provision of government services consistent with the requirements of the ARP and other applicable laws, regulations, and guidance.

NOW, THEREFORE, BE IT RESOLVED by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

SECTION 1. The Village of Crooksville, pursuant to the American Rescue Plan Act of 2021 ("ARP"), shall expend the amount of \$1,350.28 of allocated ARP Funds to Modern Glass, Paint & Tile Co., to furnish and install four Provia vinyl Ecolite series vinyl hopper style windows at the Village of Crooksville Village Park (building at the swimming pool).

SECTION 2. The Village of Crooksville Fiscal Officer is hereby instructed and authorized to take the actions necessary to implement this Resolution and file the required reports of the ARP Funds received and expended.

SECTION 3. This resolution is hereby declared to be a measure necessary for the immediate preservation of the public peace, health, and safety and welfare of the inhabitants of the Village of Crooksville and requires immediate passage to allow the Village Administrator to timely execute and enter into the Proposal from Modern Glass.




