The Village Fiscal Officer request, in accordance with Ohio Revised Code § 321.34, that the County Auditor pay over to the Fiscal Officer of the Village of Crooksville any money that may be in the Perry County Treasury for the accounts of the Village of Crooksville, for the Village's purpose of using such monies in the fiscal year 2023.
- 2. That this Resolution is effective at the earliest date allowed by law.
