RESOLUTION NO. 54-2024

A RESOLUTION AUTHORIZING THE MAYOR TO APPLY FOR, ACCEPT, AND ENTER INTO A POLLUTION CONTROL LOAN FUND (WPCLF) AGREEMENT ON BEHALF OF THE VILLAGE OF CROOKSVILLE FOR CONSTRUCTION OF WASTE FACILITIES; DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN; AND DECLARING AN EMERGENCY

Whereas, the Village of Crooksville seeks to upgrade its existing waste facilities; and

Whereas, the Village of Crooksville intends to apply for Pollution Control Loan Fund (WPCLF) funding for the planning, design and/or construction of waste facilities; and

Whereas, the Ohio Pollution Control Loan Fund (WPCLF) requires the government authority to pass legislation approving application for a loan and the execution of an agreement, as well as designating a dedicated repayment source; and

Whereas, the Village Council deems it necessary to pass this Resolution as an emergency measure, effective upon passage, in order to allow for timely submission of the loan application and entry into a Pollution Control Loan Fund (WPCLF) Agreement on behalf of the Village of Crooksville for construction of waste facilities, and for designating a dedicated repayment source for the loan, all in the best interests and general welfare of the Village of Crooksville.

NOW THEREFORE BE IT, AND IT IS HEREBY RESOLVED:

- 1. That the Mayor and Village Administrator are hereby authorized to apply for a WPCLF loan, and to sign all documents for and to enter into a Pollution Control Loan Fund (WPCLF) Agreement with the Ohio Environmental Protection Agency and the Ohio Development Authority for construction of waste facilities on behalf of the Village of Crooksville, Ohio.
- 2. That the dedicated source of repayment will be user charges.
- 3. That this Resolution is declared an emergency measure necessary for immediate effectiveness on its passage in order to allow for timely submission of the loan application and for timely entry into a Pollution Control Loan Fund (WPCLF) Agreement on behalf of the Village of Crooksville for construction of waste facilities, and for designating a dedicated repayment source for the loan, all in the best interests and general welfare of the Village of Crooksville.
