ORDINANCE NO. 2736

ORDINANCE APPROVING, ADOPTING, AND ESTABLISHING MAYOR'S COURT COSTS FOR THE MAYOR'S COURT IN THE VILLAGE OF CROOKSVILLE, OHIO

Whereas, Court Costs for the Village's Mayor's Court were last updated in 2008 and 2009, and revisions to those Costs are necessary to conform to various State requirements and to provide for sound management and efficient operations of the Village's Mayor's Court; and

Whereas, Council for the Village of Crooksville now wants to approve, adopt, and establish updated and revised Mayor's Court Costs for the Village's Mayor's Court.

NOW THEREFORE BE IT, AND IT IS HEREBY ORDAINED by the Village Council of the Village of Crooksville, Perry County, State of Ohio, that:

Section One. Council for the Village of Crooksville hereby approves, adopts, and establishes the "Village of Crooksville – Mayor's Court Costs" as set forth in the document attached hereto as "Exhibit A" and incorporated herein by reference.


Section Two. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of Council and after the required number of readings and that all deliberations of the Council and any of the decision-making bodies of the Village of Crooksville which resulted in such formal actions were in meetings open to the public and in compliance with all legal requirements of the State of Ohio.

Section Three. All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereto.

Section Four. This Ordinance shall take effect at the earliest time allowed by law.
