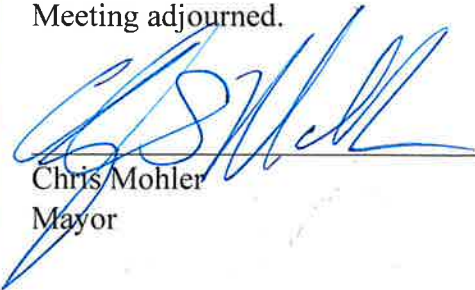

ADJOURNMENT: Without any further discussion, Mr. Redfern makes the motion to adjourn and Mr. Hampton seconds.

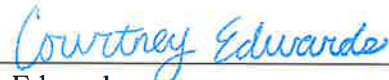
