RESOLUTION No. 40-2026

A RESOLUTION OF THE VILLAGE OF CROOKSVILLE REQUESTING THE PERRY COUNTY AUDITOR TO CERTIFY TO THE VILLAGE COUNCIL OF CROOKSVILLE THE TOTAL CURRENT VALUATION OF THE VILLAGE OF CROOKSVILLE AND THE DOLLAR AMOUNT OF REVENUE THAT WILL BE GENERATED BY THE RENEWAL OF A TAX OF 2.0 MILLS LEVIED FOR THE PURPOSE OF GENERAL MAINTENANCE AND OPERATION OF THE MUNICIPAL PARK AND SWIMMING POOL WITHIN THE VILLAGE OF CROOKSVILLE, DECLARING THE NECESSITY TO LEVY A TAX IN EXCESS OF THE 10 MILL LIMITATION, AND DECLARING AN EMERGENCY.

WHEREAS, the Crooksville Village Council, which is the Taxing Authority of the Village of Crooksville, Perry County, Ohio, and holds territory only within the County of Perry, finds the taxes that may be raised within the ten-mill limit will be insufficient to provide for the necessary requirements of the Village of Crooksville, and that it is necessary to levy a renewal tax of 2.0 mills, in excess of that ten-mill limitation, upon the entire territory of the Village of Crooksville, at the General Election to be held on November 3, 2026, for the purpose of general maintenance and operation of the Municipal Park and Swimming Pool within the Village of Crooksville, pursuant to Ohio Revised Code Section 5705.19(H); and

WHEREAS, before seeking to have a levy approved by the electors of Crooksville, the Crooksville Village Council, acting pursuant to Ohio Revised Code Section 5705.03, must request the Perry County Auditor to certify certain information to the Village of Crooksville Fiscal Officer in connection with the proposed renewal tax of 2.0 mills for the purpose of general maintenance and operation of the Municipal Park and Swimming Pool within the Village of Crooksville.

NOW THEREFORE, BE IT RESOLVED by the Village Council of the Village of Crooksville, Perry County, Ohio, as follows:


1. That the Perry County Auditor is hereby requested to certify to the Village of Crooksville Fiscal Officer the total current tax valuation of the entire territory of the Village of Crooksville, all of which is solely within Perry County, and the total dollar amount of revenue that will be generated by an renewal tax levied in the entire territory of the Village of Crooksville in the amount of 2.0 mills for five (5) years for the purpose of general maintenance and operation of the Municipal Park and Swimming Pool within the Village of Crooksville, in accordance with Section 5705.19(H) of

the Ohio Revised Code.


2. It is requested that the Perry County Auditor issue the Auditor's Certification to the Village Council of the Village of Crooksville within ten (10) days after the Auditor's receipt of this Resolution.
3. The proposed levy is a renewal levy for 2.0 mills for the purposes set forth in Section 5705.19(H) of the Ohio Revised Code and specifically for the purpose of general maintenance and operation of the Municipal Park and Swimming Pool within the Village of Crooksville.
4. The amount of the renewal levy is 2.0 mills, to be levied for five (5) years. The renewal tax shall be submitted to the entire territory of the village of Crooksville and shall be voted on at the General Election to be held on Tuesday, November 3, 2026, and the levy shall be upon the tax duplicate beginning for tax year 2027, and first collected in calendar year 2028.
5. The Village of Crooksville's Fiscal Officer and/or the Village of Crooksville Solicitor is hereby directed to certify this Resolution to the Perry County Auditor.
6. **Emergency Measure.** This Resolution is hereby declared an emergency measure necessary for the immediate preservation of the public health, peace, safety and general welfare of the citizens of the Village of Crooksville, Perry County, Ohio, and in order to allow ample time to comply with all requirements necessary to ensure submission of the issue to the voters. Therefore, this Resolution shall have immediate effect upon its passage.




